TERMS AND CONDITIONS:

In consideration of receiving the Italian Greyhound (hereafter referred to as "IG") described above from IGCA Rescue, the undersigned Adopter agrees to be bound by the following terms and conditions:

Please initial if in agreement:

_____ 1. I agree that this IG will be kept exclusively as an indoor pet and will not be used in any way detrimental to the dog (i.e., medical research, abuse, neglect, etc.).

_____ 2. In the event problems develop which would prevent me from keeping this IG, I will contact IGCA Rescue immediately and they will take the dog back unless there is another home available that is approved by the IGCA Rescue Rep. I will NOT give, sell or transfer this IG to any animal shelter, pound, humane group or laboratory. I will not give this IG to another person, nor will this IG be euthanized except in the case of the IG's terminal illness or injury, or old age accompanied by pain and suffering. Euthanasia must be performed by a licensed veterinarian.

_____ 3. I will notify IGCA Rescue immediately if this IG is lost or stolen and will make every effort to locate the IG.

_____ 4. I will provide proper food, indoor shelter, fresh water, kind treatment and care at all times and will keep this IG on leash at all times when not in a safe enclosed fenced area. I will not tie this IG out at any time nor will I leave this IG outdoors while I am away from home.

_____ 5. I will provide regular veterinary care including required vaccines, dental care and parasite checks.

_____6. I will never transport this IG in an open vehicle or in any other way that will endanger this IG during transport.

_____7. I will notify IGCA Rescue of any changes in our information, such as address and phone numbers within one month of the change.

_____8. I hereby release the Italian Greyhound Club of America (IGCA), the Italian Greyhound Rescue Foundation, Inc (IGRF), the registered owner (if known) and all others previously involved with this dog from any liability incurred from this day forward. Further, I will assume all veterinary expenses for this dog from this day forward.

_____9. I understand that IGCA reserves the right to repossess this dog (at my expense) should any portion of this contract be breached by me or should I have been found to neglect or mistreat this dog. I certify that my answers are true and correct and that falsification will breach this contract.

_____10. I agree to allow IGCA Rescue to periodically check on this IG to be assured of compliance with the above terms.

Any breach of this contract requires that the adopter return the IG to IGCA Rescue without entitlement of any refund or damages of any kind.
